- 1. Consignor must have a good title to the vehicle and be able to show the title is free and clear from all claims and liens or that the lien holder will cooperate with any sale made.**
  
- 2. Consignee agrees to pay the consignor all proceeds agreed on within 30 days of the vehicle and title have been delivered to the purchaser and all applicable fees have been paid in full. The consignee agrees to execute the transfer of title of the consigned vehicle within 4 business days of the sale pursuant to this agreement by the consignee (if we do not already have documentation in our possession).**
  
- 3. Consignee is not to be held liable for any damages that incur to the above vehicle while in its possession. Consignor is advised to maintain comprehensive and liability insurance in addition or in lieu thereof while the vehicle is in the Consignee's possession at the expense of the Consignor. The Consignor and Consignee understand that the consigned vehicle is subject to the same regulations of sales as if owned by the consignee.**
  
- 4. To properly market the vehicle and allow full exposure through marketing outlets, Kuyoth's Klassics requires the vehicle to be here a minimum of 45 days. Should Consignor wish to remove the vehicle from the Consignee's premises, we require at least 3 days' notice. The vehicle can then be removed between 9 a.m. and 5 p.m. on weekdays or subject to appointment. If the vehicle is not sold after the 45 days, the vehicle may be subject to a storage fee.**
  
- 5. The maintenance and repair of the vehicle shall be at the sole expense of the Consignor. If mechanical or maintenance work becomes necessary while the vehicle is on the Consignee's premises, Consignee will seek permission from Consignor to complete the necessary repairs. Kuyoth's Klassics charges an initial one-time fee of **\$200** for complete mechanical inspection of consigned vehicle before we can fully market vehicle.**
  
- 6. Consignor acknowledges and consents to giving Consignee the right to transport Consignor's vehicle. Consignor understands that in some situations Consignee may need to market Consignor's vehicle at automobile shows and similar events and that such marketing may for certain vehicles be essential for obtaining best sales price. Any show/entrance fees incurred will be discussed prior to event and will be approved by consignor.**
